# **Background**

- April 2019 AGM OPIRG Brock presented, CUPE donated \$10,000, and there
  was a commitment to build a committee/ stronger partnership between the 2
  organizations
- 2019-2020 The Niagara Social Justice Coalition was this committee hosting "Impacts of Ford in Niagara Campaign"
- February 2020 GMM notice of motion for a bylaw amendment
- March 12 2020 GMM
  - OPIRG Brock presented at the CUPE 4207 GMM
  - a Special Assessment Bylaw was presented that would allocate 0.25% of wages fee on top of union dues to be allocated to OPIRG Brock
  - With the approval of this, all CUPE 4207 members became OPIRG Brock members
  - A \$10,000 donation was also made to address more immediate funding concerns, as this fee could not be put in place until the Bylaws were approved by CUPE National

### Special Assessment/ working with CUPE 4207

- Starting in June 2020, CUPE National approved the Bylaws amendment and the fee started to be collected
- We wrote a Memorandum of Understanding, signed by CUPE 4207 President & the OPIRG Brock Board of Directors (rep)
- Through this process, we rewrote our membership policies, Constitution, and website to improve online services and ease usage
- At the November 2020 GMM, we presented and were posed with a question on the voting and renewal process on the Special Assessment Bylaw
- From this request, a review and voting process was worked on and proposed and approved at the March 21, 2021 GMM.
- We connected with Tracy, Nathan, Kate (CUPE 4207 member & OPIRG Brock Board member), about strategies increasing membership engagement
- We have also all been working with this team to connect with Ash at the GSA to be able to collaborate and better support our overlapping memberships
- Our team is currently working with Lina (VP Equity) on getting anti-oppression trainings set up over the months ahead

#### Access to OPIRG Brock memberships

- With the approval of the Special Assessment Bylaw, all CUPE 4207 members became OPIRG Brock members
- We have implemented a registration process so we can more easily track our membership numbers and better connect

- With the money earned through CUPE 4207 members being OPIRG Brock members, we have been able to add so many resources and partnerships

# **OPIRG Brock Updates**

- With regularly funding through the Special Assessment Bylaw, we were able to maintain our permanent unionized staff at 12.5 hours/ week and a contract bookkeeper
- We have also be able to fully overhaul our website to better resource the community and publish social justice resources
